

## Profit Guidance for the third quarter and nine months ended 31 March 2023

The Board of Directors of Lion Asiapac Limited ("**Company**") and together with its subsidiaries ("**Group**") wishes to issue a profit guidance on the unaudited financial results of the Group.

Based on a preliminary review, the Group is expected to report a loss for its third quarter and nine months ended 31 March 2023 ("**Financial Result**"). This is primarily due to escalating production costs and unrealised exchange loss arising from the depreciating Renminbi.
